Lemanik Asset Management S.A. is the Management Company to SKY Harbor Global Funds.

**Objectives and Investment Policy**

The Fund seeks to generate high risk-adjusted returns over a full market cycle through investing primarily in U.S. dollar denominated, below-investment grade corporate bonds. The diversified portfolio will be primarily constructed with a focus on current income, preservation of principal and low volatility.

The Fund may also seek to minimize the risk of negative externalities that may result from environmental, social and/or governance ("ESG") factors, while focusing on sustainability leadership, defined by transparency and disclosure of ESG criteria.

The Fund may invest in out-of-index debt securities based on the judgment of the Investment Manager; for example, securities that are CCC rated, securities that are unrated but judged to have sufficient credit quality, and securities with maturities beyond five years.

The Fund may be compared against the ICE BofAML 1-5 Year BB-B

US Cash Pay High Yield Constrained Index ("JVC4") to measure performance. It can materially deviate from the JVC4 by underperforming or outperforming it.

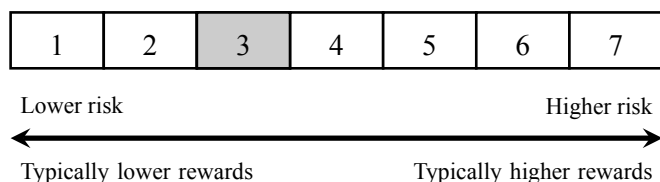
A Shareholder may redeem its shares in the Fund on demand, on each day on which banks in Luxembourg and New York are open all day for business.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within a period of 1 year.

The Fund does not intend to declare and make distributions with respect to the net investment income and realized capital gains, if any, attributable to this class. Accordingly, the net investment income of this class will neither be declared nor distributed.

The reference currency of the Fund is the USD and the reference currency of this class is the EUR. This class is hedged.

**Risk and Reward Profile**



The shaded area in the table above shows the Class' ranking based on the Synthetic Risk and Reward Indicator. The risk/return indicator suggests the relationship between risk and potential returns when investing in the Fund. The Fund has been classified as category 3 due to the nature of its investments, which include the risks listed below. This means that the purchase of units in the Fund is connected to medium risk of such fluctuations. Please note that category 1 does not mean a risk free investment. Historical data, such as is used in calculating the synthetic indicator, may not be a reliable indication of the future risk profile of the fund; the category might change in the future.

The following risks are materially relevant to the Fund but are not adequately captured by the synthetic indicator and may cause additional loss:

- Credit risk: The default of the issuer of a debt instrument held by the Fund.
- Liquidity risk: Securities in the Fund may be sold below their valuation due to insufficient liquidity in the market.
- Counterparty risk: A counterparty may fail to pay the proceeds related to the sale of securities by the Fund or may fail to deliver the securities purchased by the Fund.
- Operational risk: Failures or delays in operational processes may negatively affect the Fund.
- Event risk: Unforeseeable events such as devaluations, political events, etc.
- Non-Contagion Risk: The currency risk of this class is hedged via the use of FX forwards. All gains/losses or expenses arising from hedging transactions are borne exclusively by the Shareholders of the Share Class. More globally, all gains/losses or expenses arising from hedging transactions are borne exclusively by the Shareholders of the respective hedged share class, without affecting the Shareholders of the other Share Classes. The Fund will ensure appropriate procedures are in place to minimise contagion risk to other share class.

## Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment. The entry and exit charges shown are maximum figures. In some cases you might pay less – you can find this out from your financial advisor or distributor. As the share class has not had a full year of performance, the ongoing charges figure is an estimated figure. Ongoing charges exclude performance related fees and transaction costs including third party brokerage fees and bank charges on securities transactions. 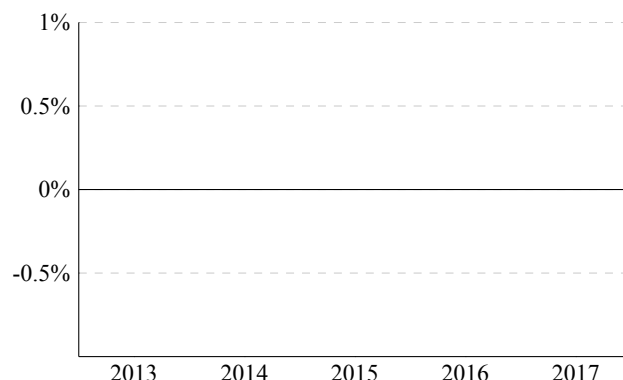
