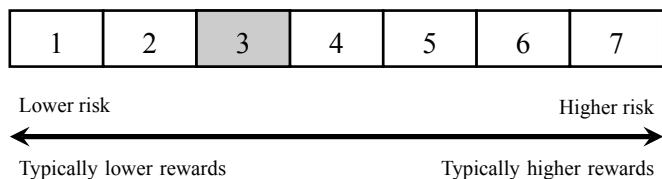
**Objectives and Investment Policy**

The Fund will invest primarily in below-investment-graded U.S. corporate bonds and seek to generate a high level of current income with lower volatility than the broader high yield market by investing in a diversified portfolio of U.S. dollar denominated High Yield corporate bonds with an average expected life of three years or less.

The Fund is an actively managed long only Socially Responsible Investment strategy that seeks to generate favorable risk-adjusted returns without reference to a benchmark. The Investment Manager shall exercise its discretion over the composition and construction of the portfolio guided by an investment process that seeks superior long-term returns built through the compounding of income over time and the avoidance of principal losses.

The investment process is rooted in fundamental analysis of issuers and industries and is complemented with the following components of Socially Responsible Investing: 1) ESG Integration using a proprietary ESG ratings score (the "Value Rubric") that includes among other things financially material sustainable criteria derived from the Sustainable Accounting Standards Board ("SASB") but also includes non-financial criteria such as gender diversity Board independence and the quality of sustainability reports/disclosures; 2) negative screening of fossil fuel and other sectors; and 3) Engagement with issuers. The Fund may invest in securities regardless of their rating and in securities which are not rated. The Fund will invest primarily in securities rated below investment grade (that is securities rated below BBB- or Baa3 by S&P and Moody's respectively). To the extent the Fund invests in securities rated below CCC or Caa by S&P and Moody's respectively the Fund shall monitor liquidity in accordance with its risk management process. A Shareholder may redeem its shares in the Fund on demand, on each day on which banks in Luxembourg and New York are open all day for business.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within a period of 1 year.

The Fund does not intend to declare and make distributions with respect to the net investment income and realized capital gains, if any, attributable to this class. Accordingly, the net investment income of this class will neither be declared nor distributed.

The reference currency of the Fund is the USD and the reference currency of this class is the EUR. This class is hedged.

The following risks are materially relevant to the Fund but are not adequately captured by the synthetic indicator and may cause additional loss:

- Credit risk: The default of the issuer of a debt instrument held by the Fund.
- Liquidity risk: Securities in the Fund may be sold below their valuation due to insufficient liquidity in the market.
- Counterparty risk: A counterparty may fail to pay the proceeds related to the sale of securities by the Fund or may fail to deliver the securities purchased by the Fund.

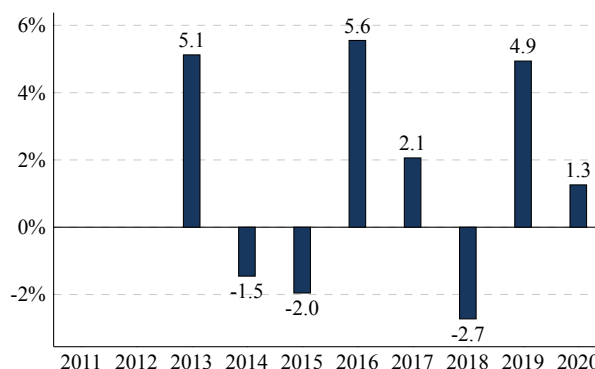
